OATH OF OFFICE AND COMMITMENT TO COUNCILLORS CODE OF CONDUCT

The first temporary Chairperson advised the Meeting that Councillors have now formally completed the statutory process for successful candidates at the 2016 Hume City Council annual election becoming Councillors.

That the minutes of the meeting record; that in accordance with Section 63 of the Local Government Act 1989, each of the Councillors present have taken the Oath of Office and made a declaration which has been signed in front of the Chief Executive officer stating that they have read and will abide by the Hume City Councillor Code of Conduct.

3. RECOGNITION OF TRADITIONAL LAND OWNERS

Cr Geoff Porter as the Second Temporary Chairperson read the following Recognition of Traditional Land Owners:

I acknowledge that we are meeting on country for which the members and elders of the Gunung-Willam-Balluk community and their forebears have been custodians for many centuries. The Gunung-Willum-Balluk of the Wurundjeri are the Traditional Custodians of this land. I would like to pay respect to the existing family members of the Gunung Willam Balluk and to Elders passed and present.

4. ELECTION OF THE MAYOR FOR THE 2016/2017 YEAR

The Second Temporary Chairperson invited nominations for the Office of Mayor for the 2016/2017 year.

Cr Karen Sherry nominated Cr Drew Jessop. Cr Jessop accepted the nomination.

There being no further nominations, the Second Temporary Chairperson declared Cr Jessop to have been duly elected the Mayor of Hume City Council for the 2016/2017 year.

The Second Temporary Chairperson vacated the chair.

There being no further nominations the Mayor declared Cr Ann Potter elected as Deputy Mayor of the Hume City Council for the 2016/2017 year.
