Road to be built through Jacksons Hill – amount of traffic coming out to go five kilometres through town to get out and in is ridiculous. When is this going to happen?

Response: (Director Sustainable Infrastructure and Services)

Yirrangan Road is the proposed connection from the southern boundary of the Jackson's Hill estate, providing access to Vineyard Road via the existing rail crossing at Watsons Road. The first stage of the project will be delivered by Development Victoria as part of the Jackson's Hill development, with the rest to be delivered by Council. The indicative schedule at this stage is for Council's section to be constructed as part of the 2020/21 Capital Works Program, however there are still several complex issues that need to be resolved before construction including the impact on major underground services, environmental impacts and property acquisition.
