Tonight, we say farewell to one of Council's Manager of Parks – Jason Summers who has decided to leave Hume to embark on his next phase.

Jason has made an enormous contribution to Local Government throughout his career spanning 23 years, 18 of those at Hume City Council. He commenced at Hume in 2002 as the Open Space Coordinator, fulfilled the role of Acting Manager Sustainable Environment and finally, 10 years as Manager Parks. His expertise also found him representing Hume City Council on numerous boards and committees, which opened up the doors to a range of collaborative partnerships.

His exemplary leadership and love of trees made the Tree Planting Program possible, resulting in the planting of over 100,000 trees in our streets, parks and facilities – one of the biggest positive impacts to help cool the City.

His accolades are endless, however the most significant being the recognition from Parks and Leisure Australia, who awarded Jason with the Greg Maddock Memorial Scholarship. This allowed him to complete a three-week study tour of Canada and North America looking at Parks Botanic gardens and Trees in urban sites, where he gained greater knowledge to bring back to Hume.

Hume's parks and reserves are in much better shape than when Jason first started as Manager, very much to the benefit of the community.

Jason, Council thanks you for your service and wishes you well in your future forestry endeavours.

### 11. PUBLIC QUESTION TIME

### PQ790 MR STEPHEN KING

#### QUESTION:

Could the councillors please update the Jackson's Creek ward residents to the current status of the proposed Hi Quality PFAS processing and storage facility on Sunbury Road and what are the Hume Council doing to prevent the proposal moving forward?

### RESPONSE: (DIRECTOR PLANNING AND DEVELOPMENT)

AT THE REQUEST OF THE MINISTER FOR PLANNING, COUNCIL PROVIDED A DETAILED SUBMISSION ON THE PROPOSED PFAS FACILITY ON 9 SEPTEMBER 2020. THE MOST RECENT ADVICE IS THAT THE PROPOSAL REMAINS UNDER ASSESSMENT BY DELWP (THE DEPARTMENT OF ENVIRONMENT, LAND WATER AND PLANNING). THERE IS NO INFORMATION ON THE FORM OF ASSESSMENT OR WHEN IT IS TO BE FINALISED.

SEPARATELY, THE MINISTER FOR PLANNING APPROVED AMENDMENTS TO THE MOORABOOL AND MELTON PLANNING SCHEMES TO FACILITATE THE DEVELOPMENT OF A PFAS FACLITY IN THOSE MUNICIPALITIES. SIMILAR APPROVALS HAVE NOT BEEN ISSUED FOR THE HI-QUALITY SITE. EPA APPROVAL OF THE ENVIROMENTAL MANAGEMENT PLAN FOR THE SITE WAS REVOKED ALONG WITH SIMILAR APPROVALS FOR THE SITES IN MOORABOOL AND MELTON COUNCIL AREAS.

COUNCIL CONTINUES TO MONITOR THE SITUATION.

#### PQ791 MR KEVIN BALAAM

### QUESTION:

Further to my Question 2 asked at the Council Meeting of 21 December 2020 where I asked about the opening of the extension of Forest Red Gum Drive, Mickleham, to the new Mickleham residential estates, have there been any traffic surveys done to compare the quantity, types, and speeds of vehicles using the rural section of that road from before and after the opening of the extension? Is any traffic modelling or analysis planned for the proposed road network into Mickleham from Craigieburn and is it publicly available?

### RESPONSE: (DIRECTOR PLANNING AND DEVELOPMENT)

AT THIS STAGE THERE HAS NOT BEEN A TRAFFIC SURVEY OF FOREST RED GUM DRIVE SINCE ITS RECENT CONNECTION TO THE ESTATE TO THE NORTH. TRAFFIC SURVEYS ARE GENERALLY UNDERTAKEN SIX MONTHS AFTER OPENING WHEN TRAFFIC PATTERNS HAVE HAD TIME TO BECOME ESTABLISHED. A TRAFFIC SURVEY OF FOREST RED GUM DRIVE, MICKLEHAM WILL OCCUR AT THIS TME.

TRAFFIC MODELLING HAS BEEN UNDERTAKEN OF THE ENTIRE HUME DEVELOPMENT CORRIDOR BY THE VICTORIAN PLANNING AUTHORITY AND THE DEPARTMENT OF TRANSPORT. THE OUTCOME OF THIS WORK IS NOT PUBLICALLY AVAILABLE.

### PQ792 MR KEVIN BALAAM

### **QUESTION:**

Has Council in the last 5-or so years received any complaints, reports or other communications from residents or other organisations (eg Melbourne Water, Yarra Valley Water) about drainage issues in the area of Axminster Drive and Farnham Court, Craigieburn, downhill to Aitken Creek, or has Council investigated any such drainage issues via internal processes? If so, what were the resultant actions and outcomes?

### RESPONSE: (DIRECTOR SUSTAINABLE INFRASTRUCTURE AND SERVICES)

FROM APPROXIMATELY DECEMBER 2016, COUNCIL BECAME AWARE OF AN ISSUE WITH AIKTEN CREEK BECOMING BLOCKED WITH OVERGROWN REEDS IN THE VICINITY OF AXMINSTER DRIVE, CRAIGIEBURN, WHICH WAS CAUSING THE LOW LEVEL PATH CROSSING BETWEEN AXMINSTER DRIVE AND CLOVELLY DRIVE TO BE BLOCKED FOR EXTENDED PERIODS. AITKEN CREEK IS THE RESPONSIBILITY OF MELBOURNE WATER AND COUNCIL REQUESTED MELBOURNE WATER TO CLEAR REEDS AND SILT EITHER SIDE OF THE CREEK CROSSING INCLUDING A MELBOURNE WATER DRAIN OUTLET TO ENSURE THAT WATER COULD FLOW FREELY.

AFTER SOME INITIAL MINOR CLEARING THAT DID NOT RESOLVE THE ISSUE, MELBOURNE WATER UNDERTOOK CLEARING AND DE-SILTING WORKS IN JANUARY 2018. MELBOURNE WATER ADVISED THAT CLEARING OF THE REEDS WAS NOW ON THEIR MAINTENANCE PROGRAM TO PREVENT THEM FROM ENCROACHING AGAIN.

### PQ793 MR GRAHAM WILLIAMS

#### QUESTION:

In October 2019 it was advised to the North West Leader newspaper that the 3rd Railway crossing at Buckland Way that "Council is looking at ways for Buckland Way link to be built sooner rather than later." No actual timeline was provided.

In light of the accelerating timeline for the railway crossing removal project in Gap Road – now slated to be completed before the end of 2023 - can council provide an urgent update on the 3rd railway crossing delivery timeline and also the status of the \$3M in funds allocated by the State Government for the project?

### RESPONSE: (DIRECTOR SUSTAINABLE INFRASTRUCTURE AND SERVICES)

THE PROPOSED YIRRANGAN ROAD PROJECT WILL CONNECT THE JACKSONS HILL ESTATE TO BUCKLAND WAY. THIS WILL PROVIDE ACCESS TO VINEYARD ROAD VIA THE EXISTING RAILWAY LEVEL CROSSING AT WATSONS ROAD.

THE ALIGNMENT OF THE PROPOSED YIRRANGAN ROAD, BETWEEN JACKSONS HILL AND BUCKLAND WAY IS CURRENTLY IN PRIVATE OWNERSHIP. BEFORE WORKS CAN START ON THE ROAD, THE SUNBURY SOUTH PRECINCT STRUCTURE PLAN AND ASSOCIATED PUBLIC ACQUISITION OVERLAY FOR ROAD RESERVE NEEDS TO BE FINALISED.

COUNCIL IS CURRENTLY UNDERTAKING PRELIMINARY WORKS SUCH AS CULTURAL HERITAGE AND GEOTECHNICAL INVESTIGATIONS AND PENDING COMPLETION OF THE PRECINCT STRUCTURE PLAN BY THE STATE GOVERNMENT, PLANS TO COMMENCE CONSTRUCTION IN THE SECOND HALF OF 2022.

THE FUNDING PROVIDED BY THE VICTORIAN GOVERNMENT'S DEVELOPMENT VICTORIA IS FOR THE SECTION OF ROAD WITHIN THE JACKSONS HILL BOUNDARY. COUNCIL PLANS TO COMPLETE THIS SECTION OF ROAD AS PART OF THE PROJECT.

### PQ794 MR GRAHAM WILLIAMS

### **QUESTION:**

In relation to the Rail Crossing Removal Project for Sunbury, the Director, Rail Infrastructure Damian Brizzi in December 2020 advised that "The project is working closely with Hume City Council on the project planning stages". Can Council please provide an update on this planning and what concrete steps are planned to minimize yet another major disruption to resident's ability to move around the township, and to the operation of businesses in the impacted areas – including Gap Road, Horne Street, Station Street and Evans Street.?

### RESPONSE: (DIRECTOR SUSTAINABLE INFRASTRUCTURE AND SERVICES)

THE GAP ROAD LEVEL CROSSING REMOVAL IS A STATE GOVERNMENT PROJECT, MANAGED BY THE MAJOR TRANSPORT INSTRUCTURE AUTHORITY. TO DATE, COUNCIL HAS ASSISTED THE AUTHORITY WITH INFORMATION AND FEEDBACK ABOUT POSSIBLE CHANGES TO COUNCIL OWNED INFRASTRUCTURE THAT WILL BE MODIFIED BY THE PROJECT AND HANDED BACK TO COUNCIL.

COUNCIL WILL CONTINUE TO ADVOCATE FOR THE INTERESTS OF RESIDENTS AND BUSINESSES IN SUNBURY, INCLUDING IN RELATION TO HOW TRAFFIC WILL BE MANAGED DURING CONSTRUCTION. HOWEVER, ULTIMATELY THIS IS A STATE GOVERNMENT PROJECT AND ANY ISSUES SHOULD BE RAISED DIRECTLY WITH THE MAJOR TRANSPORT INFRASTRUCTURE AUTHORITY.
