## BUSKING ACTIVITIES:

- The busking activity is not to obstruct any pedestrian or vehicle traffic.
- A copy of your Public Liability Insurance to \$10 million noting Councils interest must be provided with application.
- All buskers must hold a copy of the permit issued by Council and make the permit available upon request.
- The applicant may only receive a maximum of **twelve (12) permits per calendar year, one (1) per month.**
- The buskers linked to the use of a permit shall not cause any nuisance whilst conducting the busking activity.
- Buskers may give audiences an opportunity to provide voluntary donations by placing a container on their site. Buskers may not approach individuals requesting money or solicit funds in a way that is overtly offensive to members of the public.
- Buskers are only allowed to perform for a maximum of two (2) hours per day at the permitted site.
- The busker/s at the request of an Authorised Council Officer or Victorian Police Officer must cease busking immediately.
- Authorised Officers of Hume City Council or any member of the Victoria Police, may direct that a busker cease busking or relocate to another site, if the Officer is of the opinion that the performance is:
  - loud or intrusive
  - excessively repetitive
  - causing public inconvenience
  - likely to cause harm to the public or property
- Any signs placed are removed immediately after the cessation of the busking activity.
- Buskers must keep the site in use clean while they are working, ensure that their use of the site does not pose a threat to public safety and that the busking site is left in the condition that it was found.
- Buskers under the age of 16 years of age must have parental or legal guardian consent to apply for a permit. It is mandatory that children under this age have parental or legal guardian supervision at all times whilst performing.
