**A permit is required to burn off on private land less than 2 hectares in area.**  
*(Council's General Local Law No. 1 – 2013, Part 3 – Amenity, clause 3.3.1 Open Air Burning)*

### Permit to Burn Conditions:

- Application must be completed and all supporting documents supplied before your application can be processed.
- Application must be submitted three (3) weeks prior to the first date requested.
- A copy of your Public Liability Insurance to \$10 million must be provided with application.
- The permit is the responsibility of the applicant and should be made available upon demand by Victoria Police or a Council Authorised Officer.
- Applicant must satisfy Council with fire suppression requirements, e.g. hose connected to permanent water supply, knapsacks and other.
- Area around the burn site is cleared of combustible material, e.g. long grass.
- The size of the fire cannot be more than 10 cubic metres.
- The burn site must be located more than 20 metres from any neighbouring dwelling.
- The material to be burnt is dead and dry and is for fire prevention purposes only.
- The material to be burnt must have come from the property the proposed burn is to take place.
- No permits will be granted to properties less than 2 hectares in area during the CFA declared fire danger period.
- Council reserves the right to revoke this permit at any time if in the opinion of an Authorised Officer any condition of the permit is being breached.
- All burn offs must be registered with Emergency Services Telecommunications Authority (ESTA) on 1800 668 511.
- It is recommended that the applicant, letter drop the surrounding properties to notify them of the burn date.

**Compliance with the conditions of a permit does not of itself relieve the holder for a permit from liability for any damage sustained by another person as a result of any fire lit by the holder of the permit pursuant to that permit.**

- **PERMIT WILL ONLY BE GRANTED FOR A PERIOD OF 1 MONTH.**
- **NO EXTENSION WILL BE GRANTED ON EXISTING ISSUED PERMIT TO BURNS.**
- **A NEW APPLICATION WILL BE REQUIRED TO BE SUBMITTED.**

## GUIDELINES & INFORMATION

### Who can apply?

Applicants whose land is less than 2 Hectares in area may submit an application outside the declared fire danger period.

Land more than 2 Hectares - Open air burning is permitted outside of the declared Fire Danger Period without a Local Law permit to burn on land of this size and above.

### When can I apply?

Outside the Fire Danger period as declared by the Country Fire Authority.

### What Information is required?

- Current copy of public liability insurance to the value of \$10,000,000 valid for the period of the permit
- If the land is not your own property, you will need to attach documentation giving permission by the owner(s) to burn. The permission must include who has authority to carry out the work, what work is allowed and must contain the land owner's full and correct name, address (PO Box address not accepted) and all telephone, facsimile and mobile contact details.
- Event dates and times

### How do I apply?

You must complete the application and provide all relevant documentation in order for your application to be processed. You can lodge your application using the following options:
