

## **2025 FESTIVE FAVOURITES COMPETITION TERMS AND CONDITIONS**

### **STANDARD TERMS**

1. Information on how to enter and the prizes form part of these Terms and Conditions. Participation in this promotion deems acceptance of these Terms and Conditions.
2. The Promoter is Hume City Council (ABN - 14854354856) of 1079 Pascoe Vale Road, Broadmeadows.

### **WHO CAN ENTER**

3. Entry is only open to Hume residents.
4. Entrants must be over 18 years old.
5. Employees (and their immediate families) of the Promoter, including but not limited to Hume City Council staff, councillors, contractors and agencies associated with this promotion, are ineligible to enter. Immediate family means any of the following: spouse, ex-spouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, stepbrother, stepsister or first cousin.

(c) Answers must directly answer the question posted in the individual Facebook post to be eligible. You must provide your answer in the comment section of the Facebook post.
