The Preschool Field Officer program is a locally responsive approach to providing preschool services with practical advice, support and professional services to enhance service capacity to provide for the access and participation of children with additional needs. The Preschool Field Officer role is to support early childhood teachers and educators to build their skills, knowledge and confidence to plan for and include all children.

All Victorian state funded preschool programs are eligible to receive PSFO services to support the access and participation of children with additional needs in a preschool program.

Funded preschool programs are provided in a variety of settings including children's centres, long day care centres, community preschools, independent schools and a small number of government schools.

The Preschool Field Officer service (PSFO) provides, up to 10 hours, to eligible children.

The Department of Education and Training funds community service organisations and local councils such as Hume City Council, to provide PSFO services across the state of Victoria. The PSFO program utilises an outreach model that enables the PSFO to provide services within a funded preschool environment. There is no cost to the preschool program or families for the PSFO service.

### Who is the target group for the PSFO Service?

Children must be attending or about to commence a funded three or four year old preschool program for the preschool to be eligible to receive PSFO support. The target group is also inclusive of children in receipt of Early Start & Access to Early Learning funding who are attending a preschool program delivered by a degree qualified early childhood educator.



### Who is the target group for the PSFO Service?

The PSFO program defines children with additional needs as children in an education and care setting presenting with developmental concerns. Developmental concerns may be associated with any area of a child's development, such as;

- challenging behaviours
- speech, language or communication delays
- social and emotional challenges
- a diagnosed disability
- children who have or are experiencing trauma and/or vulnerability
- challenges associated with fine and/or gross motor development

### What does capacity building of early childhood educators mean?

Capacity building is provided through a range of strategies that assist the early childhood educators to plan and implement a program that is responsive to the learning and development needs of children with additional needs.

The PSFO program provides a collaborative partnership approach with early childhood teachers and educators. The partnership enables sharing and the exchange of ideas and knowledge to support a coordinated approach. The approach recognises that those who are with the child most will have a greater impact on the child's development. The PSFO program works in partnership to build educators capacity to provide young children with additional needs with the experiences and opportunities that promote their learning and development and to enable them to participate meaningfully in an inclusive learning environment.

- Gain the knowledge and skills to confidently implement practices and provide programs that are responsive to the individual abilities, interests and needs of children with additional needs in an inclusive early childhood environment
- See themselves as having both the responsibility and capability to plan for all children in the early childhood program and that it is not only experts with specialist skills who can provide support for the learning and development of children with additional needs
- Respond to parents' concerns regarding their child's development.

### Support may include:

 Provision of information and resources, and identification of adaptations, strategies and experiences to inform programming for a child with additional needs.



- Supporting an early childhood educator's identification of a child with additional needs through contributing to the observation of a child's capabilities as well as their learning and developmental needs.
- Supporting an early childhood educator's confidence and capacity to respond to a parent's concern regarding their child's development.
- Provision of planning support that respects, acknowledges and complements the educator's expertise in supporting children's learning and development.
- Coaching of an early childhood educator to assist with planning and implementation of an inclusive early childhood program that supports a child with additional needs.
- Building professional partnerships and collaborative relationships with early childhood educators.
- Modelling of specific skills, suggestions and strategies with early childhood educators.
- Assistance to an early childhood educator to embed child specific teaching and learning approaches and opportunities into the everyday early childhood environment.
- Identification of referral pathways and facilitation of linkages for families to the range of child and family supports, including more specialised assessment and services as required.

#### Do PSFO's work with families?

PSFO's recognise that families are their child's first educator, families know their child and can provide important information regarding their child's development. PSFO's can support early childhood educators to build trusting and respectful relationships with families that enable educators to plan and provide for the ongoing learning and development of children in the preschool program.

PSFO's use a range of capacity building strategies that may include acting as role models for strength-based conversations with parents regarding their child's development or acting as a support for the educator as they lead conversations with families. Part of the PSFO role focusses on building the skills and confidence of early childhood educators to respect the family as decision makers for their child and to support the early childhood educator to understand the range of services and supports available to enhance child and family functioning.

The PSFO does not directly deliver intervention to a child within an early childhood setting but acts as a consultant and coach to the early childhood educator. This approach may include contact with the child and family in the early childhood setting, recognising that this work is done with and through the early childhood educator in a manner that respects the educator's ongoing relationship with the child and family.



### Can parents contact the PSFO service?

Parents of children who attend an early childhood service who have concerns regarding their child's development are encouraged to discuss these with their child's early childhood educator in the first instance. Where a parent directly contacts the PSFO program, the PSFO will liaise with the relevant early childhood educator to progress the request for support.

### Who can request support?

- Early Childhood professionals
- Parents/Guardians in collaboration with the child's educator
- Other health care professionals with parental/guardian consent and in collaboration with the child's educator.

### **Support options**

There are now three support options available:

### 1. Individual Child – Funded Preschool Program

PSFOs can assist children who are currently enrolled and attending a State-funded four and three year old preschool program with parental/guardian consent.



### How to request support from the PSFO service

Please complete the following steps to request support for an individual child:

### 1. Discuss your concerns with the family

Please use an interpreter to have the conversations with families who do not have English as their primary language.

Educators or other professionals must discuss their reasons for requesting PSFO support with the child's parent/guardian prior to submitting the form.

### 2. Complete the referral form with the family

Please complete the form in consultation with the family, there are sections for you both to complete.

The referral forms will be emailed to each service in the Hume City Council catchment area at the beginning of each year. The forms can be accessed via dmail. Please contact us on 9205 2601 or email to psfoteam@hume.vic.gov.au for this option.

The referral form is updated every year - please ensure you send the current form. Be specific about the child's needs and what you are requiring support with.

### 3. Submit the signed form to the PSFO Service

Email or post the form to our service at the addresss provided on the form.

Once the referral has been received by the PSFO Service an email confirmation will be sent. If you do not receive a confirmation, please contact us to check receipt.

All decisions made regarding the developmental needs of the child and any further referrals required, will be made in collaboration with the family and educators.

## What will happen if an educator requests support for a child and they have commenced the pathway for Early Childhood Intervention (Brotherhood of St Laurence/NDIS) Services?

- A child who has commenced the Early Childhood Early Intervention pathway (through the Brotherhood of St Laurence or NDIS) and is waiting for service to commence, is eligible for the PSFO program.
- When Early Childhood Early Intervention service commences, PSFO involvement will cease if the service provider includes preschool visits.



### General advice without completing a request for service

You can call the PSFO program for guidance and information without completing a referral form. We can provide phone support to discuss your concerns, guide you with referral options, strategies for inclusion or how to approach parents, etc. Please don't hesitate to contact us on the numbers provided.

### 2. COMMUNICATING YOUR CONCERNS TO FAMILIES

Communicating with parents can be difficult at times, even for the most experienced Early Childhood Educators. The way you communicate can either encourage partnerships or get parents offside. A partnership works best when messages are clear, specific and considerate of the other person's feelings. Always talk to parents with the goal of strengthening relationships.

### **Approaching Parents**

- Asking a parent to talk with you, for the purpose of discussing how you can both SUPPORT
  the child, is best. Try to avoid saying you want to meet to discuss your concerns. This helps
  set the tone for the meeting.
- It is important to approach families when they are not rushing and to say what you want to say in a calm (not rushed and relaxed tone) kind of way.
- Remember: positive need positive
  - 1. Start by providing some positive feedback about the child to the family
  - 2. Discuss the child's needs/challenges in a sensitive manner
  - 3. Finish on another positive

E.g.: "I have prepared some notes on Grace's participation in the program. She is doing really well at remembering and following the routine. (Pause) I am noticing she is finding it challenging to interact with her peers. She is mostly preferring to play alone at preschool. Could we meet together so we can work out how we can best support Grace? (Pause) When can we meet?"

### Organinsing the parent meeting

- Offer to meet and discuss concerns at a time that suits the family.
- Consider who will attend provide the opportunity for both parents / grandparents/guardians to attend and arrange an interpreter if necessary.
- Be prepared have notes/observations prepared to refer to. Base these notes on the child's strengths as well as areas to work on. Have a section to note actions as a result of the meeting. This is important!
- Consider appropriate setting for meeting; ensure the family feel at ease and that the meeting is held in a confidential environment.

### **During the parent meeting**

■ Have your notes put away in a folder/diary or similar so that you can listen well to the parents without focusing first on what you want to say. The family should talk first about their child. Listening well to the family allows you to hear where they are at with their understanding of their child's learning and development and can give you a place to begin, depending on what the family says e.g. Yes, we've noticed that Ashaz can have trouble talking with his peers at preschool too. I know what you mean... and so on.



### 2. COMMUNICATING YOUR CONCERNS TO FAMILIES

- Remember to let families know at every opportunity that they know their child best. You are after their input to understand the situation better.
- Remind families that the purpose of the meeting is to share information with each other, and to work out how to support their child.
- State the factual information you have observed at preschool.
- Ask questions as to how this information compares to the child when at home / in other social settings.
- Relate this to child development information.

The PSFO service can be accessed (phone or email) if any Educator requires further advice or support with this. A referral form does not need to be submitted for you to receive this support.





Hume commenced transition to the National Disability Insurance Scheme (NDIS) March 2018, which means there are changes in the way Early Childhood Intervention Services (ECIS) are accessed and how service providers are funded. Children can no longer apply for state-funded ECIS and can now be referred to the early childhood approach (formerly Early Childhood Early Intervention/ECEI).

The Brotherhood of St. Laurence (BSL) is the early childhood partner (EC Partner) of the NDIS in our municipality. This means that you may see BSL with NDIS on paperwork.

The early childhood approach supports children younger than 7 years of age with developmental concerns or disability in Hume/Moreland. This includes those who may be eligible to become participants of the NDIS.

Children do not need a diagnosis to be referred to the early childhood approach. Children younger than 6 without a diagnosis may be eligible to access the NDIS. Children who are 6 years and over and do not have a diagnosis may be supported by our early childhood team to link in with local mainstream and community services.

### What is the early childhood approach?

Our early childhood approach recognises, as parents and carers, you are central in supporting your child's development. The early childhood approach aims to:

- provide timely support to ensure that you are able to access the supports you need
- give you information about best-practice early childhood intervention supports and how you can help your child
- increase your confidence and capacity to manage and respond to your child's support needs
- increase your child's ability to do activities they need or want to do
- increase your child's inclusion and participation in mainstream and community settings like playgroup, childcare, kindergarten or preschool
- give you information about, and referrals to, other support services, like parent support groups
   to meet other people with similar experiences or situations, if you want to.

The early childhood approach can be delivered by a range of professionals with specialist qualifications who apply their knowledge and expertise to support children to learn and develop.

The professionals supporting a child may include:

**Occupational Therapist** – Their specialist knowledge can contribute to supporting the development of a child's independence in everyday activities including eating, dressing, toileting and a range of activities that are part of family life.

**Physiotherapist** - Their specialist knowledge can contribute to supporting a child's development in the areas of movement, posture and balance.

**Speech Pathologist** – A speech pathologist will work in supporting a child who has difficulties talking, understanding speech, stuttering, eating and drinking, swallowing or drooling.

**Psychologist** – Their specialist knowledge can assist families to support a child's social, emotional and overall development. They can provide advice and assistance to families including offering behaviour management guidance.

**Specialist Early Childhood Educators** – Professionals who are trained in early years education are often part of early childhood teams and assist families to understand their child's needs and to provide opportunities and experiences that support their learning and development.

### Who provides the early childhood approach in the Hume/Moreland region?

The NDIS has engaged early childhood partners (EC partners) around Australia to deliver the early childhood approach. EC partners are teams of allied health professionals and early childhood educators. The Brotherhood of St. Laurence is the EC partner for Hume and their contact details are:

### How does it work? Information for families

You (family or professionals supporting the family) can contact the Brotherhood of St. Laurence if you have concerns about your child's development or if you would like to discuss your child's needs. They can help you to get information and access to supports. The referral form can be completed online or on paper – please see link below.

The family and other caregivers will be provided with ideas on ways to help your child with their everyday living.



As every child is different, the Brotherhood of St Laurence will tailor support to your child's individual needs and circumstances.

The early childhood team will:

- Connect you and your child with the most appropriate supports in your area, such as the community health centre (IPC Health), educational setting or playgroup.
- Assign an early childhood coordinator (EC coordinator) to meet with you to gather some general information about you and your child. This meeting can happen in your home, in the community or in our office. As part of this initial conversation, you can discuss your concerns about your child's development. Your early childhood partner will help you get the right level of support for your child's needs.
- Provide a short period of early supports where it has been identified as the most appropriate support. Early supports are designed to build capacity in you and your child to promote everyday learning.
- Help you to request NDIS access if your child requires longer-term early childhood intervention supports. If your child becomes an NDIS participant, the EC partner will work with you to develop an NDIS plan.
- Develop your plan: help you to work out your goals and identify the supports you need to help reach those goals.
- Get your plan going: once your plan has been approved, the EC team will work with you to help you get your supports set up and working. They might help you to set up your MyGov and My NDIS Participant Portal account and show you how to manage and monitor your NDIS funds.
- Keep in touch with you, if you need help with your plan: the EC team will keep in touch with you and check in to see how you are going with using your plan, and if you have been able to access the supports, such as therapy or equipment, that your child needs.



### Who can refer to ECEI?

- Early Childhood Educators (with parent permission)
- Parents/Carers
- Other service professionals (with parent permission) such as MCH Nurses, GP's, PSFO's.

### 4. DPV - CHILD HEALTH SERVICES

### What is a Community Health Service?

A community health service works in partnership with the local community to provide responsive, interconnected health and community services. It is a not-for-profit organisation.

DPV Health provides the following services for children and families:

- Psychology (for children)
- Family Services
- Podiatry
- Counselling Services (for parent)
- Dental Services
- Speech Therapy
- Occupational Therapy
- Paediatricians

### Occupational Therapy:

Paediatric Occupational Therapists look at the activity's children take part in their everyday life. They help children to take care of themselves (self-care) participate in preschool and learning (productivity) and enjoy life/leisure (play). They can help children do activities by themselves, so they feel confident when participating at different activities at Preschool.

### Speech Pathology:

Paediatric Speech Pathologists work with families to help children communicate. They can help support children who have difficulties with their language (understanding and using spoken language), difficulties with saying sounds clearly, social conversation skills and stuttering.

### **Psychology:**

The psychologist works closely with parents to help them support their child's development at home. Parents are encouraged to work with the psychologist to help improve their child's capacity for learning, socialisation and play skills, build emotional regulation or resilience skills and increase their child's cooperation.

### **Podiatry:**

If your child is suffering from any lower leg symptoms, exhibits an awkward gait or walk, has flat feet, uneven shoe wear, poor posture and stability a pediatric podiatrist may be able to help you. No age is too young to visit a podiatrist.



### 4. DPV - CHILD HEALTH SERVICES

### **Audiology:**

An audiologist deals with ear-related problems, specifically balance disorders and hearing loss that affect infants and children. Audiologists are often considered as "hearing doctors" since their main specialty is the assessment, diagnosis, treatment, and management of different kinds of hearing losses, which may develop for several reasons. Further, since the ears also help in achieving balance, audiologists are also trained to handle balance disorders.

### When should I refer to DPV Health for Child Health Team?

Eligibility is determined by the standards outlined by the Department of Health for Community Health Services.

- Children referred to the Child Health Team ARE ELIGIBLE if they have MILD needs in either hearing, communication or motor skills.
- Children are NOT ELIGIBLE if they are suspected of having OR already have a diagnosis of Autism Spectrum Disorder, Global Developmental Delay, need ongoing therapy for more than behaviour difficulties, or are eligible for another service like Early Childhood Early Intervention (ECEI/NDIS).

If there are concerns about moderate to significant delays in one or more developmental areas, a discussion about service options (other than DPV Health - Child Health Team) is in the best interests of the child and family, to ensure the most appropriate service is accessed as early as possible.

#### Referrals for DPV

Both Parents, MCHN and Educators are able to put in a referral via email to the Child Health Team. If educators put in the referral on behalf of the child please;

- Start communicating with parents/carers as early as possible about observations of the child
- Record examples and dates of your observations
- Invite parents/carers to share any similar observations they may have had
- Explain that referral to a service such as DPV Health is about finding the best service to support the needs of the child and family
- Express that the objective is to enable the child to be 'school ready' and focus on the skills needed for school

### 4. DPV - CHILD HEALTH SERVICES

#### **Paediatricians**

DPV Health also has three paediatricians (there is a waitlist). The services of the paediatricians will be bulk billed, however GP referral is required. The GP referrals can be sent, faxed or emailed.

#### **Paediatric Fellow**

DPV Health has a number of Paediatric Fellows who are in their final year of training with the Royal Children's Hospital and WILL see children without Medicare cards. The Paediatric Fellows are only at DPV for one year. They can consult and give recommendations ONLY; they do not diagnose. A GP referral is not required but there is a Referral Form available through RCH.

Educators and other professionals such as MCH and Speech Pathologists can refer to the Paediatric Fellows program with parent/carer consent.

### Referral to Fellow in Community Child Health

# 5. SUNBURY COMMUNITY HEALTH - CHILD HEALTH SERVICES

### What is a Community Health Service?

A community health service works in partnership with the local community to provide responsive, interconnected health and community services. It is a non-for-profit organisation.

Sunbury Community Health provides the following services for children and families:

- Family Services
- Audiology
- Dental Service
- Speech Therapy
- Physiotherapy
- Podiatary
- The Enables program

The Child Health Team offers individual and group services. Please see the tip sheet tab for further information on what Sunbury Community Health offers.

### Physiotherapy:

The Sunbury Physiotherapist mostly works with babies under 2.

### **Paediatric Speech Pathologists**

Paediatric Speech Pathologists work with families to help children communicate. They can help support children who have difficulties with their language (understanding and using spoken language), difficulties with saying sounds clearly, social conversation skills and stuttering. This is not an ongoing service. This service offers group work.

**Podiatry:** Phone 9744 4455 for service. Health Care Card holders free.



# 5. SUNBURY COMMUNITY HEALTH - CHILD HEALTH SERVICES

### When should I refer o Sunbury Community Health?

Eligibility is determined by the standards outlined by the Department of Health for Community Health Services.

- Children referred to the Child Health Team ARE ELIGIBLE if they have MILD needs in either hearing, communication or motor skills
- Children are NOT ELIGIBLE if they are suspected of having OR already have diagnosis of Autism Spectrum Disorder, Global Developmental Delay, need ongoing therapy for more than behaviour difficulties, or are eligible for another service like Early Childhood Early Intervention (ECEI/NDIS)

If there are concerns about moderate to significant delays in one or more developmental areas, a discussion about service options (other than Sunbury Health) is in the best interests of the child and family, to ensure the most appropriate service is accessed <u>as early as possible</u>.

### **Obtaining Parental/Carer Consent**

Parental/carer consent is a requirement for referral to Sunbury Community Health. It can sometimes be difficult to initiate conversations around consent with parents/carers. The following tips may facilitate these conversations:

- Start communicating with parents/carers as early as possible about observations of the child
- Record examples and dates of your observations
- Invite parents/carers to share any similar observations they may have had
- Explain that referral to a service such as Sunbury Health is about finding the best service to support the needs of the child and family
- Express that the objective is to enable the child to be 'school ready' and focus on the skills needed for school

How do I make a referral to Sunbury Community Health for a Child Health Service (Physiotherapy, Speech, Pathology and Psychology, Audiology, Dental)?

### 6. NDIS EARLY INTERVENTION AGENCIES

Families can self-refer once they have their NDIS plan. Early Intervention Agencies typically have Speech Pathologists, Occupational Therapists, Special Education Teachers and Physiotherapists as part of their team. These services are operated using the Key Worker model, that includes working with children's services and in the family home or elsewhere in the community, including Kindergarten as decided upon by the family.

### 7. PAEDIATRICIANS

### Who is a Paediatrician?

A Paediatrician is a doctor who specialises in children's health and development.

### When do you refer to a Paediatrician?

A referral to a Paediatrician would be made to gain support for any child showing concerns related to their learning, growth or development.

#### Who can refer to a Paediatrician?

To see a Paediatrician a referral must be gained from the family doctor (GP).

Once a referral is made by the family doctor, the parent is required to make contact with the Paediatrician's office to make an appointment.

See the following list for some of the Paediatricians in the area that the family can contact.

Families may be able to obtain Medicare rebates - the Paediatrician's rooms will be able to advise the family.

### **Paediatric Fellow Service at DPV**

You can also make a referral to the Paediatric Fellow Service who is based at DPV. Please see details on Page 16.

A Paediatric Fellow is a doctor who is completeing additional training to become a Paediatrician and conducts clinics at IPC Health Services under the auspice of the Centre for Community Child Health and the Royal Children's Hosptital as part of their training. It is a different person each year.

Appointments with the Paediatric Fellow are free to families but appointments are limited and there are particular criteria to be eligible.

### 8. OCCUPATIONAL THERAPISTS (OT)

Paediatric occupational therapy focuses on helping children develop skills which enable them to achieve the best of their abilities in areas including independence in self-care, sensory processing and fine motor skills.

The term 'occupational' in occupational therapy refers the the 'occupations' of our daily life. For a child this usually is preschool, school, self-care or play.

### Who can refer to an Occupational Therapist?

A parent can call and make an appointment for their child.

DPV have an Occupational Therapist. They mainly see children with fine motor challenges prior to starting school.

This is not usually an ongoing service. Fees may apply, depending upon your family's income level. Services is free for low income families or Health Care Card holders.

### How do you refer to private Occupational Therapist?

Contact the therapist directly.

### 9. SPEECH PATHOLOGIST

A Speech Pathologist sees children who experience difficulties with talking or understanding language, including the social use of language as needed in conversing with others, asking for help etc. Advice is available to families in regard to encouraging language development at home. Speech Pathologists also work with children who have problems eating, drinking or other oral motor issues.

### When do you refer to a Speech Pathologist?

Speech therapy support would be necessary for a child who has speech and language delays. These may be in expressive language (i.e. the child's ability to express themselves and be understood by others) or receptive language (i.e. the child's ability to take in and process language to understand instructions etc.).

It is important to check if the child is having difficulty hearing if there are concerns about the child's speech and language development.

### Who can refer to a Speech Pathologist?

A parent can call and make an appointment for their child.

### How do you refer to a Speech Pathologist?

Contact the Pathologist directly.

Both DPV and Sunbury Community Health have paediatric Speech Pathologists. It is important to know that these services are not usually ongoing and may be group based. Fees may apply, depending upon your family's income level.

Services are free for low income families or Health Care Card holders. See the list following for some of the private Speech Pathologists in the Hume area who the family may contact.

Please Note: Charges may apply, please contact the service direct for more information. This list is not exhaustive and the **PSFO Service do not endorse any service listed.**

Free hearing tests are available through DPV and Sunbury Community health. These are bulk billed and require a referral from a doctor.

### 10. PSYCHOLOGISTS

The psychologist monitors children's overall development by observing and understanding progress in learning alongside behavioural, emotional and social development. The psychologist may also be available to help if there is some concern about a child's emotional well-being and behaviour or difficulties within the family.

### When do you refer to a Psychologist?

- Involvement from a psychologist would occur when a child is displaying difficulties with their behaviour and/or interaction with their peers in a social setting.
- A child who requires support with emotional and/or social development including stress and anxiety issues may also benefit from the services of a psychologist.

### Who can refer to a Psychologist?

A parent can call and make an appointment for their child.

### How do you refer to a Psychologist?

Parents are able to contact the therapist directly or through the family doctor. See the list following for some of the Psychologists in the Hume area who the family may contact.

Please Note: Charges may apply, please contact the service direct for more information. This list is not exhaustive and the **PSFO Service do not endorse any service listed**.

Please note that a referral from your GP is usually required for you to gain an appointment with a Psychologist.

## 11. HOW TO GET MEDICARE REBATES FOR SEEING THERAPISTS

## CHRONIC DISEASE MANAGEMENT PLAN (formerly known as an Enhanced Primary Care Plan)

- Medicare rebate for a maximum of five allied health services per patient each calendar year from eligible providers. Additional services are not possible in any circumstances.
- A patient must have a GP Management Plan (GPMP)
- Your GP will decide whether you would benefit from these services and, if so, will refer you for appropriate allied health services
- Allied health services must be provided by eligible providers who are registered with Medicare Australia.

### **MENTAL HEALTH TREATMENT PLAN**

- Medicare rebates are available for up to 10 allied mental health services per calendar year to patients with an assessed mental disorder under the Better Access initiative.
- Must be referred by a GP managing the patient under a GP Mental Health Treatment Plan.
- Allied mental health services under this initiative include psychological assessment and therapy services provided by clinical psychologists.

### **HOW DO I GET ONE OF THESE PLANS?**

- You need to visit your GP and ask the Doctor to complete a Chronic Disease Management Plan or a Mental Health Treatment Plan. You may need to book an extended consultation.
   To support your request, ensure your GP is aware that your child has ongoing difficulties.
- Your GP will then complete the required paperwork, which includes the referral to the allied health professional (i.e. speech pathologist, psychologist, physiotherapist, audiologist or occupational therapist). You can request a particular allied health professional if you have found one you want to see, or alternatively your GP will send you to one they know.

### WHAT HAPPENS NEXT?

- Contact the allied health professional to make an appointment and say you will be using a Chronic Disease Management Plan or a Mental Health Treatment Plan.
- When you make your first appointment with the therapist, take your referral form from the GP with you.
- When you pay for the service you must receive a receipt which includes the therapist's name and provider number as well as details of the referring GP.
- You can submit this to Medicare to receive the rebate.
- NOTE: You will need to register your bank details to receive a rebate from Medicare

# 13. ACCESS TO EARLY LEARNING (AEL) & EARLY START KINDERGARTEN (ESK)

### **Access to Early Learning:**

The Access to Early Learning (AEL) program is designed to support vulnerable families to sustain engagement in preschool and to improve the learning outcomes in the home.

### **Procedure:**

Children identified for participation in AEL must have at least two or more of the following family characteristics in order to be eligible:

- Known to Child Protection/Child First
- Intellectual or physical disability of the child or parent
- Family Violence
- Mental Health Issues
- Sexual Assault
- Alcohol and Drug Abuse

There may be other factors, such as homelessness, young parenthood and social isolation, which are considered in combination with the above characteristics.

Eligible children must turn three by 30 April of the year of attendance. If the child is not eligible for AEL, the facilitator will work with the family and referrer to identify other services to support the family, such as Early Start Kindergarten (ESK)

### **Early Start Kindergarten Funding (ESK)**

The Early Start Kindergarten program is designed to maximise access to two years of quality early childhood education and care prior to school for vulnerable children and children identified as Aboriginal and/or Torres Strait Islander.

Early Start Kindergarten Program eligibility criteria are:

- Children are aged three by 30 April in the year they will be attending a preschool program.
- Children are Aboriginal and/or Torres Strait Islander, or
- The family has had contact with Child Protection (or has been referred by them to Child First)

# 14. ABORIGINAL & TORRES STRAIT ISLANDER SUPPORT SERVICES

### **Koori Education Worker KESO**

The role of the KESOs is to help build the capacity of Victorian schools and early learning services to provide culturally welcoming and safe learning environments where koori students can participate fully, achieve their best, and graduate to post-secondary education and training pathways.

KESOs support by the facilitation and engagement between school, families, students, key stakeholders and organisations, building and strengthening the relationships between them. KESOs work closely with Senior Education Improvement Leaders (SEILs) to implement and deliver the Regional Marrung Implementation Plan.

This includes delivery of Cultural Understanding and Safety Training to education providers across North Eastern Melbourne and Hume Moreland areas. The KESOs is also available to guide and support schools to develop Individual Education Plans (IEP) for all koori Students. Other priority areas for the KESOs include:

- Offering cultural audits to all schools and early learning centres within their networks
- Supporting services and families to access 3 and 4-year-old preschool programs while promoting all DET Early years initiatives
- Support supported playgroups
- Engage with Maternal Child Health coordinators
- Attend student support group meetings for koori Out of Home Care students as per LOOKOUT Centres processes
- Promote opportunities for families to engage in relevant committees, councils and groups.

# 17. PLAYGROUPS PROVIDED BY HUME CITY COUNCIL

Supported Playgroups provide opportunities for parents of children from birth to 5 years to learn about relevant local services, meet with other parents for emotional support, friendship and to build social support networks in the communities in which they live.

Supported Playgroups are funded by the Department of Health and Human Services.

### Eligibility

To be enrolled in a Supported Playgroup, families must be referred into the group and meet at least one of the following eligibility criteria:

- families in which a family member identifies as Aboriginal and/or Torres Strait Islander
- families looking after children in kinship care arrangements (out of home care)
- families referred from Child FIRST/Child Protection
- families in isolated communities
- families experiencing stress and disadvantage
- families with children who have additional needs
- families must have a Commonwealth Health Care Card/Visa requirement
- families supported by the Enhanced MCH service

## 19. KINDERGARTEN INCLUSION SUPPORT (KIS) PACKAGES

An inclusive preschool fosters the development of a sense of belonging and respects individuality and diversity to promote learning, development and well-being in a child's early years.

The objective of the 'Kindergarten Inclusion Support Packages' is to build the capacity of funded preschools to support the access and participation of children with a disability, high support needs or with complex medical needs.

The support from the 'Kindergarten Inclusion Support Packages' is in addition to the existing resources available to the preschool educators and may not provide full coverage of all costs.

### The 'KIS' program:

- provides assistance to complement early childhood teacher knowledge and skills, while acknowledging their expertise in supporting children's learning and development
- supports early childhood teachers to build their capacity to develop and implement an inclusive program
- supports early childhood teachers to contribute to positive outcomes for children, as defined in the Victorian Early Years Learning and Development Framework
- responds to the child's abilities and strengths, as well as their needs by supporting the preschool to enhance their learning and development
- inclusive programs encourage and allow all children genuine opportunities to access and participate in preschool programs

### The range of support available through the 'KIS' package program includes:

- Specialist training
- Specialist consultancy support
- Minor building modifications
- Additional staffing support

The Preschool Teacher needs to complete the application. Parents are required to sign the application and support the educator to gather information about the child when completing an application.
