## ADDITIONAL NOTES

- Building Permit fees are based upon actual building work cost and are calculated on either the minimum fee or a percentage of building work cost (as determined by MBS office) — whichever is the greater.
- Building work cost means contract price, or where there is no contract price, the MBS estimated real market value of in accordance with S205 of the Building Act 1993. Where there is disagreement a registered Quantity Surveyor report will be required or reference to the Building Appeals Board by applicant.
- Building Permit and inspections fees incur GST (except Lodgement fee and the Building Permit Levy)
- Building Permit fees are rounded up to next \$10.00— e.g. \$1,656.42c rounds up to \$1,660.00 plus GST
- 20% Seniors, Pensioner and Concession card holder discount applies to Building Permit and non-statutory Building Control fees (documentary evidence required).
- All applications are property land title specific. Additional properties incur additional fees.
- Municipal Building Surveyor discretion applies to professional fees proposals.

## PLAN AND DOCUMENT COPYING CHARGES

The fee applicable to Copy of Plans, Documents or Certificates includes the following services:

- Administration ➤ Archive search & retrieval
- Uploading or emailing of documents

If hard copies are required, additional copying fees are as follows:

A4 = \$5.00 per sheet      A3 = \$7.00 per sheet      Large sheets = \$40.00 per sheet

Where more than one Building permit file is required additional fees may apply.
