A permit is required for a person to camp on private property with an existing dwelling for a period longer than 6 months.

(Council's General Local Law No.1 – 2023 - Division 1 - Your Property, Clause 37)

Camping on private property Application Conditions:

- Application must be completed and all supporting documents supplied before your application can be processed.
- If Applicant is not the land owner, written consent from the land owner must be provided with the completed application.
- Sanitary facilities located inside the caravan or premise to be used at all times.
- Camping not to be used for permanent place of residence, permits will only be valid for a maximum period of 12 months.
- Camping Site/Caravan only to be occupied by the approved number of occupants at any time.
- The permit is subject to review on receipt of any substantiated complaint.
- Any power to be supplied to the caravan is to be maintained as per relevant regulations.
- Ensure caravan does not cause a detrimental effect to the amenities of the area.
- Ensure waste water can be effectively disposed of so as not to cause an odour/nuisance.
- No more than one tent or caravan will be allowed on the land at any one time.
- Permits will only be issued for private land. No permit will be issued for roads or municipal places.
- Council reserves the right to revoke this permit at any time if in the opinion of an Authorised Officer any condition of the permit is being breached.

GUIDELINES & INFORMATION FOR CAMPING ON PRIVATE PROPERTY APPLICATIONS:

Who can apply?

Anyone looking to camp or occupy a caravan on private property where there is an existing dwelling for a period longer than 6 months can apply for the permit.

When can I apply?

Applicants may apply once they have obtained all the required information and documentation required with this application for it to be processed.

What does Council take into consideration when assessing an application?

- The applicant's proposed means of hygiene, sanitary requirements, garbage disposal and power are satisfactory.
- The number of people camping/occupying the caravan.
- The location of the campsite/caravan on the land.
- · Reason for camping on the land.
- · Length of intended camping.
- Any objections to the application.

How do I apply?

You must complete the application and provide all relevant documentation in order for your application to be processed. You can lodge your application using the following options:
