#### 8. PUBLIC QUESTION TIME

#### PQ1101 PUBLIC QUESTION - MICHAEL RUSSO

Council have recently released their Street Tree Planting Map for 2024 and have noticed a lot more gum trees are going to be planted along Melrose Drive & Broadmeadows Road in Tullamarine. Considering these are entry points/ main roads onto Tullamarine can council consider changing these trees to more appealing, exotic trees for example Pistacia chinensis?

#### **RESPONSE – ACTING DIRECTOR INFRASTRUCTURE & ASSETS**

Pistacia chinensis does not tolerate waterlogging which is essential for a tree to succeed within the Hume City Council area. Pistacia chinensis also does not tolerate tree root pruning which is essential for any street tree in highly urbanised areas.

There is a selection of tree species chosen for Melrose Drive and Broadmeadows Road, some trees could be classified as gum trees, others are ornamental pears, bottle brush trees or Banksia trees depending on the available space.

Hume City Council is aiming to have a high diversity of street tree species within the city in order to future proof the tree population from large scale decline and death due to pest and disease incursion and/or our warming climate. Therefore, Council includes both native and non-native trees within our planting program. If a road is wide enough and the planting space is not under powerlines Council maximises future tree canopy by planting a larger tree rather than a small or medium sized tree (Urban Forest Principles 2020). Native street tree species attract more native birds and insects and provide corridors for our native birds to flow between conservation reserves.

The current program illustrated on the map is not changing the character of either street, but rather replacing similar trees with other trees of similar characteristics.

#### PQ1102 PUBLIC QUESTION - MICHAEL RUSSO

Does council have any plans to upgrade the Fisher Gr Park in Tullamarine in the near future?

#### **RESPONSE: ACTING DIRECTOR CITY PLANNING AND PLACES**

Council manages many parks and open spaces across Hume and regularly receives requests for improvements. Unfortunately, not all these requests can be addressed immediately.

Council's annual Playspace Replacement & Open Space Upgrade Program addresses the replacement of ageing playspaces. Priorities are reviewed annually and are determined based on age, an independent safety audit, maintenance reports and community feedback. Fisher Grove Reserve is not currently on the renewal program for the next few years.

Recent upgrades in Tullamarine include Churchill Ave Park (2023) and Dalkeith Ave Reserve (2021).

Planned renewals or upgrades will occur in the next few years at Derby Street Reserve, Tadstan Drive Reserve and Lackenheath Drive Reserve.

Background Information:

The plan for Aitken Boulevard extension in Mickleham includes a concrete Shared Use Path along it. Up near Donnybrook Road, a length of the road and path has been opened, another is under construction, but the section further down in the semi-rural area appears to have been delayed. Botanical Estate by Satterley "might" provide a walking and cycling route across Mt Ridley Road and up north through to the existing housing. 2. The recent Donnybrook Road/Mitchell St upgrade by State Government did not include any walking or cycling infrastructure despite (when the Cloverton Boulevard bridge across Merri Creek is completed) this length of a few hundred metres being the "gap" in the walking and cycling network providing Mickleham residents access to Donnybrook Station.

Could Council please provide an update on any projects that improve walking and cycling access between Craigieburn and the residential areas of Mickleham around Donnybrook Road?

Can you please explain why the Regulations are so confusing?

Checklist as noted in Schedule 1 of the Local Government Planning and Reporting Regulations refer to performance reporting to Council, not to Local Government Victoria.

#### PQ1109 PUBLIC QUESTION - MELINDA O'NEILL

Does Hume City Councils Waste Service Charge comply with the Minister's Good Practice Guidelines for Service Rates and Charges that came in to effect on 1 March 2024?

#### **RESPONSE – CHIEF FINANCIAL OFFICER**

In relation to the question raised, it's important to note that Council's budget was set in June 2023, whilst the Ministerial Good Practice Guidelines (the guidelines) were issued in December 2023, after Council had adopted the 2023/24 Budget.

Council fully complies with the Local Government *Act*, all Essential Services Commission (ESC) requirements, the relevant legislations and was fully transparent with all community engagement undertaken.

Council is currently working in cooperation with Local Government Peak bodies to evaluate how the guidelines may affect Hume. Subsequent to these assessments, any required actions will be identified and addressed.

It is also important to note that the guidelines are not legislated, but rather, serve as an expression of what the Minister deems to be good practice in applying Service Rates and Charges.

#### PQ1110 PUBLIC QUESTION - MELINDA O'NEILL

#### **RESPONSE – CHIEF FINANCIAL OFFICER**

The ministerial guidelines outline examples of the types of costs that provide a general benefit to the whole municipality and should be funded by councils through revenue sources other than a Service Rate or Charge, these include:

- litter and waste collection from public spaces and the provision of public bins;
- street, footpath and drain cleaning;
- graffiti removal;
- municipal tree planting and maintenance;
- general and/or municipal environmental activities such as park maintenance,
- public education and advocacy.

Of the listed activities above, litter bin collection from public spaces and the provision of public bins, street sweeping and public education initiatives are covered by Council's waste charge.

Background Information:

For nearly 60 years, Melbourne Youth Orchestras (MYO) has been Victoria's leading provider of ensemble music education for young people aged 8 to 25 years of age.

The program is open to students across Victoria and has provided performance and training opportunities for Hume musicians, including most recently students at Hume Central Secondary College.

In addition to this, for the past 14 years, the Melbourne Symphony Orchestra (MSO) has run a separate, complementary program of music tuition specifically for young people in Hume called the Pizzicato Effect.

This program has provided music tuition free-of-charge for approximately 60 Hume students each year.

In 2023, the State Government funding allocated to both of these programs was removed. The Melbourne Youth Orchestra's \$200,000 grant was discontinued, and the Melbourne Symphony Orchestra discontinued funding to the Pizzicato Effect entirely.

It is recognised that the MSO have established a new program in place of the Pizzicato Effect, called 'Jams in Schools'. This program seeks to reach more students across Victoria, engaging them in interactive performance sessions, however is will no longer offer dedicated music tuition programs, leaving a significant gap in creative pathways for young people in Hume.

A group of community volunteers and parents are working to continue some version of the Pizzicato Effect in Hume; however they have no public funding confirmed at this stage.

The impact of losing funding for dedicated youth orchestras, and dedicated tuition programs such as the Pizzicato Effect, means that

young musicians in Hume lose access to important pathways to further their education and pursue creative development.

**THAT Council notes:** 

- a. In its Creative Community Strategy 2020-2025 Hume City Council aspires to be a natural home for creative practitioners, and to support pathways to careers in the arts, particularly for people who face barriers to participation.
- b. The classical music programs, previously funded by the State Government, have provided essential pathways for aspiring musicians from Hume, especially those from disadvantaged and vulnerable backgrounds.
- c. The Victorian Government's decision in December to discontinue \$200,000 in funding for Melbourne Youth Orchestras limits both the opportunity for young people to participate in targeted musical education, it also limits pathways for disadvantaged young people to pursue careers in music and performance.
- d. Likewise, the Melbourne Symphony Orchestra's decision to defund the Pizzicato Effect will impact negatively on local creative development and opportunity.
- e. Without publicly-funded classical music programs, like Melbourne Youth Orchestras and Pizzicato Effect, aspiring musicians from Hume whose families are not in a position to pay for private tuition face greater challenges in pursuing their musical education.
- 2. Directs officers to write to the-write to the Minister for the Creative Industries, the State Members for Broadmeadows, Greenvale, Kalkallo and Sunbury and the CEO of Melbourne Symphony Orchestra to:
- a. highlight the importance of both programs for Hume community.
- b. call on the Victorian Government to reinstate the \$200,000 of funding recently removed from Melbourne Youth Orchestras.
- c. advocate for funding and support for the Pizzicato Effect to be reinstated in Hume given its immense proven benefit to Hume, and Broadmeadows students in particular.
