- serving of coffee, tea (with or without milk, soy, almond, or any other liquid), alcohol, water, soft drink (except fermented soft drinks containing a live culture) intended for immediate consumption but does not include unpasteurised processed fruit or vegetables (e.g., fresh juice) or any drink which has any other potentially hazardous food added, such as unpasteurised egg.
- the handling and serving of food at a family day care service premises, residence, and approved family day care venue within the meaning of the **Education and Care Services National Law Act 2010 (Victoria)**.
