QUESTION 1:

It has been 3 years since it was advised in the State Budget. Can you please provide an update with an exact timeline for the transfer of Sunbury Arts and Cultural Precinct land and buildings to Council from the state government and the cause of any delays?

RESPONSE: (DIRECTOR COMMUNITY SERVICES)

HUME CITY COUNCIL IS REPRESENTED ON A MULTI-AGENCY STEERING COMMITTEE TO SUPPORT THE FUTURE PLANNING OF THE JACKSONS HILL DEVELOPMENT.

THE TRANSFER OF LAND TO SUPPORT THE SUNBURY ARTS AND CULTURAL PRECINCT LAND IS BEING LED BY THE DEPARTMENT OF ENVIRONMENT, LAND, WATER AND PLANNING (DELWP) AND THIS WORK FORMS PART OF THE JACKSONS HILL MASTERPLAN WHICH WAS COMPLETED BY THE VICTORIAN PLANNING AUTHORITY IN 2018.

TO SUPPORT THE DEVELOPMENT OF THIS IMPORTANT AND COMPLEX SITE, DELWP IS CONTINUING TO ADVANCE THE PREPARATION OF REQUIRED BACKGROUND REPORTS AND A PLAN OF SUBDIVISION TO FACILITATE THE TRANSFER OF LAND AND ASSOCIATED BUILDINGS.

WHILST IT IS DIFFICULT FOR COUNCIL TO SPECULATE WHEN THE LAND AND BUILDINGS WILL BE TRANSFERRED, COUNCIL CONTINUES TO UNDERTAKE ITS OWN PRE-PLANNING WORKS TO ENSURE THAT IT IS READY TO PROCEED AS SOON AS THE LAND IS TRANSFERRED.

IT IS COUNCIL'S UNDERSTANDING THAT THE DELAY IS PRINCIPALLY COVID RELATED.

HUME CITY COUNCIL HAS ESTABLISHED A COMMUNITY ADVISORY GROUP IN MID 2020 TO SUPPORT THE PLANNING AND DEVELOPMENT OF THE SUNBURY COMMUNITY ARTS AND CULTURAL PRECINCT PROJECT.

THE MEMBERS OF THIS GROUP REFLECT A BROAD RANGE OF INTERESTS, EXPERIENCE, SKILLS AND COMMUNITY CONNECTIONS. THIS GROUP HAS REPERSENTATIVES FROM THE ARTS NETWORK, SUNBURY ABORIGINAL CORPORATION, JACKSONS HILL PRIMARY SCHOOLS, SUNBURY COMMUNITY RADIO STATION, SUNBURY YOUTH AND INTERESTED RESIDENTS. THE GROUP HAS BEEN APPOINTED TO ADVANCE THE INITIAL VISIONING WORK WHICH WAS UNDERTAKEN IN 2015.

SINCE THE ADVISORY GROUP WAS ESTABLISHED, THEY HAVE MET ON FOUR OCCASIONS. THE GROUP WILL CONTINUE TO MEET TO HELP SHAPE AND INFORM THE PLANNING PROCESS AND BROAD COMMUNITY INPUT WILL ALSO BE SOUGHT, AS THE PROJECT PROGRESSES.

Can officers please provide the report number and meeting date where it was decided that the public toilet in Green Street, Bulla should be demolished?

THE REMOVAL OF THE PUBLIC TOILET AT BULLA WAS AN OPERATIONAL DECISION, TAKEN DUE TO ONGOING ANTI-SOCIAL BEHAVIOUR OCCURRING ON SITE AND THE POOR CONDITION OF THE FACILITY.

COUNCILLORS WERE ADVISED OF THE INTENTION TO REMOVE THE FACILITY IN JUNE 2019 AND SIGNAGE WAS ERECTED AT THE SITE TO ADVISE THE PUBLIC PRIOR TO DEMOLITION. THE TOILETS WERE DEMOLISHED IN AUGUST/SEPTEMBER 2019.

THE SITE WORKS INCLUDE THE FOLLOWING:

THREE FULL SIZE RUGBY LEAGUE AND TOUCH FOOTBALL PITCHES AND ONE TRAINING PITCH. A PAVILION WITH CHANGEROOMS FOR NRL VICTORIA AND THE NORTHERN THUNDER RUGBY LEAGUE CLUB. IN ADDITION, THERE WILL ALSO BE OFFICE SPACE FOR NRL VICTORIA AND A COMMUNITY FACILITY ON THE SECOND LEVEL AND LANDSCAPING AROUND THE BUILDING AND PITCHES WITH A TOTAL COST OF \$19.4 MILLION.

THERE WILL BE A FURTHER \$3.2 MILLION FOR THE PLAYGROUND, RECREATION AREA, PUBLIC AMENITIES, MULTI COURT, PATHWAYS AND ADDITIONAL LANDSCAPING.
